YOU ARE REQUIRED AND EXPECTED TO BE OPEN AND SERVING YOUR APPROVED FOOD PRODUCTS DURING FESTIVAL HOURS:

- FRIDAY, AUGUST 11 4:00 PM TO 10:00 PM
- SATURDAY, AUGUST 12 10:00 AM TO 10:00 PM
- SUNDAY, AUGUST 13 10:00 AM TO 3:00 PM

YOU MUST HAVE A PERMIT WITH THE ST JOSEPH COUNTY HEALTH DEPARTMENT. YOU MUST BE SET UP BY 2:00 PM ON FRIDAY AND BE PRESENT FOR INSPECTION. YOU MUST PASS ST JOSEPH CO HEALTH INSPECTION AND MEET THEIR REQS. YOU MUST USE A BACK-FLOW PREVENTOR TO CONNECT TO OUR WATER SUPPLY. YOU MUST HAVE CONTAINERS FOR GREASE AND OIL DISPOSAL. YOU **CANNOT** USE OUR TRASH OR DUMPSTER RECEPTICALS FOR GREASE OR OIL DISPOSAL. YOUR BOOTH AREA MUST BE KEPT NEAT AND CLEAN. LANGUAGE, ACTIONS AND APPEARANCE MUST BE ALWAYS PROFESSIONAL. YOU MUST HAVE AN UP-TO-DATE FIRE EXTINGUISHER IN YOUR BOOTH. GENERATORS CANNOT BE USED UNLESS THERE IS A PARK POWER INTERUPTION. **VENDORS MUST USE DUMPSTERS FOR TRASH DISPOSAL. NO GREASE OR OIL. TRASH BARRELS ARE FOR YOUR PATRONS.** PLEASE BE POLITE AND RESPECTFUL TO FESTIVAL PERSONNEL VENDORS MUST EXIT PARK WITH TRAILER AND ALL EQUIPMENT BY 8:00 PM SUNDAY EVENING.
